The Organization provides screening services for the City of Cupertino's Below Market Rate program. The Organization operates Vista Village, a twenty-four unit housing comlex for low income families. The Organization operates a four-plex for the working homeless men and for homeless women with children. The Organization provides intensive case management to homeless individuals and families to connect them with resources to secur housing and other basic needs.

BASIC NEED SERVICES

The Organization accepts donations that are passed to individuals and families in the community on an as needed basis for emergency assistance. The Organization also provides a food pantry that is stocked by food from Second Harvest Food Bank, local grocery stores, and community donations. The food pantry is staffed by volunteers who pick up and distribute food annually to families and individuals. The Organization works closely wit a variety of local agencies to provide families with information and referral services, and to help the emergency need of lower income familie residing within the community.
